## **GUIDELINES FOR BODY DONATION**

- 1. After death, a consent form should be prepared stating the willingness to hand over the body to the Anatomy Department of Govt Medical College Kottayam for study purposes.
- 2. The **consent form** should be prepared on a stamp paper of Rs.50.
- 3. An **attested photo** of the donor should be pasted on the stamp paper.
- 4. Clear signature or thumb impression of the donor should be recorded in the consent form.
- 5. In addition, the names and signatures of all legal heirs (husband, wife and children) of the donor must be recorded.
- 6. All the aforesaid signatures should be recorded in the presence of any two witnesses.
- 7. Witnesses should be properly informed regarding body donation by the donor.
- 8. Witnesses must record their name, address and signature.
- 9. A **copy** of this document should be signed by the HOD of the dept of Anatomy and kept with the donor.
- 10. Original should be given to the head of the department of anatomy through the principal of the medical college, either directly or by post.
- 11. A copy of the donor's **Aadhaar card** should be submitted along with above mentioned document.
- 12. After the death of the donor, the **death certificate** and a copy thereof should be brought along with the body by the concerned. The copy is meant to be kept in the anatomy section.
- 13. The death certificate must be issued from a registered medical practitioner.
- 14. Only bodies that have died of natural causes and are not damaged can be used for study purposes.
- 15. Bodies subjected to post-mortem or have undergone organ donation (other than eye donation) are not accepted.
- 16. Bodies affected by deadly diseases such as AIDS, hepatitis B, etc. will not be accepted.
- 17. It should be declared in the document that once the body is received by the Anatomy department the body will not be reclaimed by the relatives
- 18. The working hours of the Medical College and Anatomy department are from 9 am to 4 pm.
- 19. If the death occurs after 4 pm or on a holiday, keep the body in the medical college hospital mortuary or a mobile mortuary for preservation and then bring it to the anatomy department
