15% AIQ SEATS IN PRIVATE DENTAL COLLEGES AND FOR
PIMS, PALAKKAD**

In continuation to this office notification dated 15.08.2026, it is further notified that the facility for Option Registration/Deletion/Re-arrangement is available on the website of the Commissioner for Entrance Examinations up to **24.08.2026, 11.00 AM**. The candidates who have not yet registered any options can register new options and those candidates who have already registered options can rearrange/delete existing options, if required. Based on the options received up to **24.08.2026, 11.00 AM**, provisional allotment will be published on **25.08.2026** and the final allotment will be published on **27.08.2026**.

Option registration facility is available for the 15% All India Quota seats in self financing dental colleges, irrespective of domicile. The allotment to these seats will be subject to Government approval. Palakkad Institute of Medical Sciences (PIMS), Palakkad has been included in this phase of allotment for MBBS Courses. The Annual Fee (Provisional) for the Palakkad Institute of Medical Sciences (PIMS) is Rs.8,98,800/-(General Category) and Rs.21,65,720/- (NRI Category).

The candidates whose results have been withheld due to various reasons can also register their online options for allotment. But the options submitted by such candidates will not be considered for allotment unless they produce the required documents to clear the defects and release their ranks before **3.00 PM on 23.08.2026**.
