SPECIFICATION

LED VISION MONITOR

- Should have LED Monitor of 18.5 inches which is remote operated.
- Should have the following charts:
Snellen charts, Log Marchart, Numeric , Alphabet , Dot chart, Contrast sensitivity, Pediatric chart, Masking test, ETDRS contrast, Ishihara colour test, Cartoon charts, Red-Green or Duochrome , Peripheral acuity .
- Should have available distances of **6 feet, 8 feet, 12 feet, 15 feet, and 20 feet**.
- Should have eye educational charts about **LASIK, Cataract, Retina, Cornea, and Contact Lens**.
- Should operate on **200–240 V, 50/60 Hz power supply**.
- Should have a certificate from a competent authority such as **CE / FDA (US) / STQC C3 certificate / STQC S certificate** or a valid detailed **electrical and functional safety test report from ERTL**. copy of the certificate / test report shall be produced along with the **technical bid**.
